APPLICATION for "Minor Dimensional" VARIANCE

York Zoning Ordinance 18.8.2.10 "provides the Appeals Board with a limited degree of flexibility to help property owners better utilize their property for building purposes". A variance under this section may be granted **only** for 1) road frontage and 2) setbacks from property boundaries **and** the variance may not reduce the dimensional requirement to less than 80% of the originally required measure **and only if** the property is not located in whole or in part in the Shoreland Overlay District.
