What's next for the Steering Committee?

What is the steering committee going to be doing after the Comp Plan is unveiled?

- Thursday, April 21
This is the consultant's deadline to finish the plan and submit it to the client. The Planning Board will review it for one week.
- Thursday, April 28, during a regular Planning Board meeting
The Plan will be officially unveiled and presented to the Planning Board. The executive summary will be discussed. CivicMoxie and CPSC are urged to come to this meeting.
- Thursday, May 12, during Planning Board meeting time
CompFest. After May 12, the Planning Board takes the written Plan out of the hands of CPSC.
- May and June
There will be opportunities to talk to the public to get it geared up about the Comp Plan. This is called being on the road.
- Thursday, June 23, during a regular Planning Board meeting

This will be the first public hearing. It will be followed by a discussion of what the Planning Board likes, doesn't like, and what they want to change or have explained. This process will include tweaking.

- July 28, during a regular Planning Board meeting
This will be the second public hearing. The Planning Board will take recommendations from CPSC and CivicMoxie. The Planning Board will make final decisions and tweaks at that time.
- Leading up to the November ballot, the public will have the opportunity to read the Comp Plan in its final format.
