5. New Business

1. Donna and James Makuc, 32 Freeman Street—Map 0023 Lot 0109

This application is for demolition per Section 12.17 of the York Zoning Ordinance.

The applicant wishes to demolish and replace a section of the home.

Scott Stevens confirmed that neither Kari Laprey nor Donald Rose has a conflict of interest.

- Motion: Kari Laprey moved to accept the application for 32 Freeman Street, Map/Lot 0023-0109, as complete for consideration. Donald Rose seconded the motion. Without further discussion, the motion carried 3-0.

Scott Stevens opened and closed the public hearing. No one came forward to speak.

During deliberation, Kari Laprey stated that the house is not located in a designated historic district nor on the National Register of Historic Places.

- Motion: Kari Laprey moved that 32 Freeman Street, Map/Lot 0023-0109, is not of sufficient architectural or historical significance to warrant the pursuit of alternatives to

35 demolition per Article 12.17. Donald Rose seconded the motion. Without further
36 discussion, the motion carried 3-0.

**2. Tim DeCoteau representing Deborah J. Fitzpatrick, Trustee
8 E. Main Street, Mayfield, NY 10542**

8 Freeman Street. Map 0023 Lot 0113

This application is for demolition per Section 12.17 of the York Zoning Ordinance.

The applicant wishes to demolish and replace a section of the home.

43 Scott Stevens qualified that no commission members had a conflict of interest. It was
44 determined that the agenda contained a mistake. The application is for the complete demolition
45 of a cottage.

46 Scott Stevens opened and closed the public hearing for 8 Freeman Street, Map/Lot 0023-0113.
47 No one came forward to speak.

48 Tim DeCoteau described the cottage's unusual construction, which would make it very difficult
49 to bring up to code.

- Motion: Kari Laprey moved to accept the application for 8 Freeman Street, Map/Lot 0023-0113, as complete for consideration. Donald Rose seconded the motion. Without further discussion, the motion carried 3-0.

53 The commissioners deliberated on the significance of the cottage.

- Motion: Kari Laprey moved that 8 Freeman Street, Lot 23-113, is not of sufficient historical or architectural significance for the HDC to pursue alternatives to demolition under Article 12.17. Donald Rose seconded the motion. Without further discussion, the motion carried 3-0.
