

SENIOR CITIZENS ADVISORY BOARD MINUTES OF THE MEETING ON NOV. 18, 2025

MEETING CALLED TO ORDER: 09:03 AM

ATTENDANCE: Verbal and signed membership all present.

ACCEPTANCE OF THE MINUTES OF THE MEETING FROM SEPTEMBER 12, 2025:

OLD BUSINESS: None

NEW BUSINESS: Chair Meyers has reached out to follow up with SOS, which has not met since February. She mentioned it is not a formal committee organization, but made up of volunteers and due to Jamie Robies retirement, the Police Dept. has not formally designated her replacement.

Greg Fyfe who is a member of the Community Center Committee updated the Advisory Board on their progress. They met on October 15, and were to vote on what their plan was for VES closure and the middle school starting at Grade 6. Their survey that was sent out, found pushback from parents who don't want their children there at the grade 6 level. Greg Fyfe's committee met on Oct 16, 2025 with school authorities to determine when they would vacate VES but they didn't have firm date, other than they will not continue to occupy the building. The Capital Budge Comm. Met and the renovations to VES is still around 40+mil. 8 mil for renovation, 2 pools and double gyms est. at 33 mil. Soft cost 3.8 mil with 3.7 in continuance fund. The community committee will be looking to establish a Capital Campaign non-profit within a year or so, to help raise contributions to off-set costs to achieve the goal. VES has significant land, plenty of parking, central location to schools and village community. Their goal would be to bring it to the voters in May of 2027. With bonding available, the cost to the average household would be approx. 275.00 in taxes.

Chair Meyers updated members on applications received for the Boston Post Cane. She has asked Maxine Brown to get applications out to various

organizations, Elks, VFW, Legion of which she is a member. Meyers had tried reaching out to Sentry Hill to no avail. York Housing has had applications available should anyone there be eligible.

Chair Meyers has had an inquiry into CAL not only having a sanitizer dishwasher, but also a regular dishwasher. It is in the 2026 budge for CAL so she will follow-up with Peter Murray on Nov. 20 for any updates.

Shout out to Table of Plenty with their impending expansion of Tuesday evenings from 1st and 3rd of each month, starting in 2026 with regular weekly Tuesday evening dinners to foster socialization, loneliness, community and food insecurity. All are welcome, coffee, tea, lemonade, drinks start at 4:00 PM, dinner served at 5:00 PM sharp.
