Tents, Canopies and Umbrellas</b></p> <p>Tents, canopies, and umbrellas are regulated on all public beaches from June 15th through Labor Day and shall meet the following standards:</p>

Bardwell</b> 2347</p> <p><input type="radio"/> _____ Write-in</p>	<ol style="list-style-type: none"> <li>1. Beach umbrellas are permitted.             <ol style="list-style-type: none"> <li>a. The term umbrella refers to a collapsible shade no greater than eight (8) feet in diameter stretched over hinged ribs radiating from a central pole no greater than seven (7) feet six (6) inches in height.</li> </ol> </li> <li>2. Canopies or sport-brellas are permitted.             <ol style="list-style-type: none"> <li>a. The term canopy or sport-brella refers to a device designed to provide shade that is no greater than five (5) feet high by seven (7) feet wide by five (5) feet deep and without grounding wires or ropes that extend beyond the perimeter of the device.</li> </ol> </li> <li>3. Umbrellas, canopies or sport-brellas shall be safely anchored and secured to the ground.</li> <li>4. Umbrellas, canopies or sport-brellas shall not be setup prior to 9:00am. An umbrella, canopy or sport-brella setup prior to 9:00am shall be subject to removal.</li> <li>5. Umbrellas, canopies or sport-brellas shall not be used to reserve space on a beach. Any umbrella, canopy or sport-brella that is left unattended for greater than 1.5 hours shall be subject to removal.</li> <li>6. Easy-up or pop-up tents are prohibited.             <ol style="list-style-type: none"> <li>a. The term easy-up or pop-up tent refers to any structure which has four corner poles and is greater than four (4) feet wide by four (4) feet long.</li> </ol> </li> </ol>
<p><b>TWO:</b> The town hereby ordains a new ordinance entitled, "Municipal Parks Ordinance."</p> <p><input type="radio"/> YES 3075</p> <p><input type="radio"/> NO 973</p>	<p><b>Section 4-B. Sleeping on Public Beaches</b></p> <p>The use of the public beach for sleeping or camping is prohibited between the hours of 12 midnight and sunrise.</p>
	<p><b>Section 9. Trash Disposal</b></p> <p>The disposal of diapers, bottles, cans, cigarette butts, garbage or rubbish of any kind is prohibited on all beaches, except in receptacles placed by the Town along the beaches, for the purpose.
